<b>Provision:</b> <ul style="list-style-type: none"> <li>➤ Provide a timetable for pupils and talk this through with them;</li> <li>➤ Monitor engagement with blended learning;</li> <li>➤ Monitor the effectiveness of Blended Learning Strategies by canvassing stakeholder feedback;</li> <li>➤ Provide feedback to pupils on work set;</li> <li>➤ Provide additional support for pupils with SEND e.g. via weekly phone calls / emails;</li> <li>➤ Provide a curriculum that meets the needs of your child's well-being, mental health and academic needs;</li> <li>➤ Provide access support for blended learning as appropriate;</li> <li>➤ Ensure that blended learning provision is in place for all pupils.</li> </ul>	<b>Attendance:</b> <ul style="list-style-type: none"> <li>➤ I will ensure my child is available to learn remotely at the times set out through the class timetables;</li> <li>➤ I will report any technical issues to the school as soon as possible;</li> <li>➤ I will report absence by calling school;</li> </ul> <b>Learning behaviour:</b> <ul style="list-style-type: none"> <li>➤ I will ensure my child uses the equipment and technology used for remote learning as intended;</li> <li>➤ I will have high expectations of my child's attitude to learning; Support good behaviour, ensuring their children understand and value the meaning of good behaviour.</li> </ul>	<b>Be ready to learn:</b> <ul style="list-style-type: none"> <li>➤ Be ready to learn online at the times set out in my timetable;</li> <li>➤ Behave well at all times to stay safe and learn well;</li> <li>➤ Take Care with a positive attitude to learning. This means: Taking Care of Myself, Others, My Work, School and the World;</li> <li>➤ Use good language;</li> <li>➤ Do my live home learning in a room other than my bedroom;</li> <li>➤ Wear suitable day time clothing.</li> </ul>
<b>Communication:</b> <ul style="list-style-type: none"> <li>➤ Communicate between home and school through newsletters, text, email, TEAMs and the school website;</li> <li>➤ Make sure we listen to parents/carers' concerns and do our best to help.</li> </ul>	<b>Communication:</b> <ul style="list-style-type: none"> <li>➤ Read all letters/messages/emails that are sent home;</li> <li>➤ I will inform the school immediately of any changes to parents/carers and emergency contacts details.</li> <li>➤ Communicate through <a href="mailto:office@berryhill.notts.sch.uk">office@berryhill.notts.sch.uk</a> for general enquires and for learning related questions through class emails e.g. <a href="mailto:class6mail@berryhill.notts.sch.uk">class6mail@berryhill.notts.sch.uk</a></li> </ul>	<b>Ask for help:</b> <ul style="list-style-type: none"> <li>➤ Tell an adult if I feel poorly;</li> <li>➤ Tell an adult if I can't get online as soon as possible;</li> <li>➤ Talk with my parents/carers and teachers about any worries.</li> </ul>
<b>Safety:</b> <ul style="list-style-type: none"> <li>➤ Adhere to relevant policies at all times;</li> <li>➤ Ensure that Data Protection procedures are followed;</li> <li>➤ Adhere to the Staff Code of Conduct at all times;</li> <li>➤ Ensure that effective safeguarding procedures and practices are in place;</li> <li>➤ Talk to pupils about how to stay safe online.</li> </ul>	<b>Safety:</b> <ul style="list-style-type: none"> <li>➤ I will ensure that I keep up to date with how to keep my child safe online (see school website E-Safety pages) protecting my child from the risks associated with using devices connected to the internet.</li> <li>➤ I will ensure that parental controls are in place at home so that my child can access the internet safely.</li> <li>➤ I will report any concerns I have about the safety of provision from school to the Designated Safeguarding Leads via the school office. <a href="mailto:office@berryhill.notts.sch.uk">office@berryhill.notts.sch.uk</a></li> </ul>	<b>Stay safe:</b> <ul style="list-style-type: none"> <li>➤ I will only use any equipment and technology for remote learning in the way my teacher / TA says;</li> <li>➤ I will ask for help from the TEAMs Class Chat pages if I need it;</li> <li>➤ I won't record, store or distribute video material without permission;</li> <li>➤ I will talk to an adult if anyone is not using online learning safely.</li> </ul>
