Factors to help determine if incident constitutes bullying

- Incident was bullying if all 3 warnings below are confirmed
 - Hurt has been deliberately/knowingly caused (physically or emotionally)
 - o It is a repeated incident or experience or the involvement of a group
 - o Involves an imbalance of power:
 - target feels s/he cannot defend her/himself, or
 - perpetrator/s exploiting their power (size, age, popularity, coolness, abusive language, labelling/name calling, etc.)
- □ Incident was cyberbullying if messages of an intimidating, humiliating or threatening nature were sent or left on a social networking site
- □ Incident was not bullying on this occasion because it was:
 - o the first hurtful incident between these children
 - o teasing/banter between friends without intention to cause hurt
 - o falling out between friends after a quarrel, disagreement or misunderstanding
 - o conflict that got out of hand
 - o activities that all parties have consented to and enjoyed (check for coercion)

- 6. What were you doing before the incident took place?
- 7. Can you remember exactly what happened or what was said?
- 8. What happened next?
- 9. Has this happened before?
- 10. What would you like to happen now?
